NCLEX-PN – TESTING RESULTS – AS OF DECEMBER 31, 2023

Summary results for the quarter ending December 31, 2023, are listed. These indicate that the passing rate for West Virginia candidates for the quarter ending December 31, 2023, is 84.39%. Records reflect 410 West Virginia candidates with 346 passing. The National passing average for the quarter ending December 31, 2023 was 86.68%. Once again, the State is below the National Average. Also, provided is a listing of individual schools passing rates in WV. Staff will be happy to respond to any inquiry's members may have regarding this concern.

Cabell Career and Technical Center supplied a copy of the schools' initial application for a new program. The school was closed after their last class graduated in September 2023, due to noncompliance with series 10 Rules. The school has now requested to reopen under the direction of a new coordinator who assisted the last class in completion. The class was successful with a 100% pass rate, 9 out of 9.
